THE SCTP HOSTED A TOTAL OF 1,336 LOCAL, STATE, REGIONAL AND NATIONAL EVENTS WITH 13,521 ATHLETES PARTICIPATING IN THESE EVENTS. THERE WERE 89,410 EVENT ENTRIES AND 8,133,056 CLAY TARGETS WERE THROWN DURING THESE EVENTS.
